AN ACT TO AMEND THE CSUN BYLAW CHAPTER 1207: UNIVERSITY LIBRARIES SPONSORSHIP; & CSUN BYLAW CHAPTER 402: ANNUAL OPERATING BUDGET

WHEREAS, the Consolidated Students of the University of Nevada (CSUN) represents all 25,000+ undergraduate students enrolled at the University of Nevada Las Vegas; AND

WHEREAS, the Senate of the Consolidated Students of the University of Nevada, under the authority of CSUN Constitution VI.D.01, is "empowered to enact any legislation that falls under the jurisdiction of CSUN"; **AND**

WHEREAS, the University Initiatives committee is empowered to manage and review of Sponsorships as maintained within the Bylaws; AND

WHEREAS, the University Initiatives committees has determined that the University Libraries no longer requires the funds provided under Chapter 1207 of the CSUN Bylaws; AND

WHEREAS, Chapter 1207 of the CSUN Bylaws was established to provide funds to the University Libraries to pay for costs associated with extended study hours access to Lied Library during study week and finals week of each Fall and Spring Semester; **AND**

WHEREAS, the CSUN Bylaws contains account information not pertinent to public concerns in Chapter 402 of the CSUN Bylaws; AND

THEREFORE, BE IT ENACTED that the following amendments to the CSUN Bylaws shall reflect the rescinding of the University Libraries sponsorship and removal of account information not pertinent to

public concern. Whereas, CSUN requests a refund on sponsorship funding for any funds that were not utilized for the extended hours sponsorship (University Libraries Sponsorship) since COVID-19 as to be coordinated with the CSUN Business Coordinator.			
ADDENDUM A			
CHAPTER 1207: UNIVERSITY LIBRARIES SPONSORSHIP			

SECTION 01: PURPOSE

- A. The purpose of this sponsorship is to provide funds to the University Libraries to pay for costs associated with extended study hours access to Lied Library during study week and finals week of each Fall and Spring Semester.
- B. Increasing access for students to be successful during their undergraduate careers is a shared commitment between CSUN and the University Libraries and this sponsorship honors that commitment.

SECTION 02: FUNDING

- A. \$3,500 shall be allocated, and starting with the semester of passage, \$1,750 shall be disbursed each fall and spring semester, not later than mid-semester as defined by the Academic Calendar, to the University Libraries for the purposes defined in Section 01 of this chapter.
- B. Any unused funds will be returned to UNLV CSUN Student Government by the University Libraries.

SECTION 03: REQUIREMENTS

- A. The University Libraries will ensure all advertisements associated with the extended hours prominently bear the UNLV CSUN logo.
- B. The University Libraries shall coordinate with a representative from the Executive Branch as designated by the President to provide for shared marketing of the extended hour program.
- C. After each two-week extended study period a written summary must be provided to the President of CSUN and the Advisor within four weeks of the last day of Finals Week.
- D. At the first meeting of the regular semester following each extended hour period, the University Libraries must provide an in-person report to the CSUN Senate.
- E. Every two semesters, the sponsorship shall be considered and reviewed by the CSUN Senate.
- F. In the event the University Libraries decides to cease the extended hours program, this sponsorship shall be immediately revoked.
