Business Manager Smercina discussed the goals in-depth, focusing on what this executive board would like to continue as goals from the previous session as well as creating our own, such as updating the bylaws and constitution. In addition to the operating documents, a discussion of the partnerships with community organization.

Vice President Carr discussed steps and goals for the executive board and what she would like to accomplish as the Vice President this upcoming year.

President Marie discussed potential standing executive board meetings on the Thursdays one week prior to the general council meeting. This would allow for discussions at the meetings to be included on the agendas for council as well as for the executive board to call for updates and finalize the council agenda for posting within the bounds of Nevada open meeting law.

Treasurer Lopez discussed the recurrence of executive board meetings, we can always place them on the agenda and cancel or postpone them as need be so that we meet Nevada open meeting law if we do see that we need more regular executive board meetings.

President Marie discussed the travel budget for the upcoming year with it being a legislative session and how the president and treasurer will have to travel to Carson City to present information on GPSA.

Vice President Carr discussed the process of the upcoming legislative session and asked if we would be doing what GPSA did in 2023. GPSA does not have the budget for a trip like that this upcoming fiscal year.

Business Manager Smercina brought up that there will be operational changes to how the GPSA email will be ran switching to a ticketing system so that GPSA can show the work we are doing and how we are helping students.
