Dylan: One of two debate presidents. Focuses on what debate team does. Debate team had large endowment, but it has stopped. Funding for awards for students during event for debating. Funding for scholarship for non-debate team members to learn for \$500; not asking for funding on the item. Funding for NFA national is important and at half cost. Membership has grown. Organization does outreach and encourages students to orusue debate. Mentions summer camp

held by team. Mentions benefits for members outside of campus. Wants CSUN to have more involvement and for CSUN with community through debate. Certain line items are half cost as per the operating policy. Talks about budget items.

Chair: asks about second excel budget sheet

Dylan: states that debate team RSO did not want to submit budget for unplanned/unknown future items but included excel sheet separately for budget understanding

Chair: Bill needs amendment to allow RSO more funding as it may be done due to agenda.

Advisor: Due to smaller number of undergraduates number, funding may be smaller

Dylan: 34 members is confirmed

Chair: awards cannot be funded as it goes to high school students and not undergraduates.

Dylan: need help due to loss of endowment and would like full amount

Chair: up to committee for approval

Flores: Would give as much money as they need, but with minimal remaining funding for other RSOs, it would be unfair to other RSOs. Senate is more strict with criteria, so could be difficult

Chair: Can talk to Scholarships and Grants committee to get scholarship for students and UI for other initiatives on campus. CSUN likes sponsorships, but other outlets to help out organization. Will allow committee to discuss

Flores: Similar situation has been presented before in senate with large RSO and W&M could lower amount

Dylan: we can lower, but would appreciate any amount

Vice Chair: should they be given more time to confirm if members will be in nationals

Dylan: not enough time for confirmation

Roberts: How many more will qualify?

Dylan: few more students are expected beyond last years 4 members

Advisor: Meeting space costs is larger, would it be something for undergraduates

Julia: Other president. Space is for students when SU doesnt have space for RSO finals during competitions

Dylan: need to pay for judges and hire them

Flores: Who is participating in conference space

Dylan: students are high school junior and senior and from other colleges students. Helps with

recruitment of students to UNLV

Flores: Only able to fund if it goes to undergraduate students. Funding can go to undergraduate judges and meeting space may be more difficult

Julia: meeting room also serves undergraduate students

Chair: falls under funding and fundraising for events for undergraduate students in operating policy.

Roberts: Could RSO reach out to high school students to pay their share?

Dylan: could replace items on budget to adjust

Flores: would be problematic in W&M and in senate as amount goes over budget

Chair: Suggest committe not go too much over

Flores: even if we go over, senate will force budget down to amount required by operating policy. Similar situation occured during senate meeting and W&M was scrutinized. Trophies canot be funded so budget will be amended.

Chair: let the W&M go to recess for all

Flores: I move to make a recess to make a certain amount of time for 5 minutes.
